OCCUPIERS LIABILITY ACT AND TRESPASS TO PROPERTY ACT

These two pieces of legislation have been approved by the provincial government, have received royal assent and will be proclaimed in September, 1980.

Basically, the Occupiers Liability Act will relieve the landowner from liability for the person, such as a hiker, who enters upon the land with the owner's permission for recreation purposes.

The Trespass to Property Act provides clear guidelines for the posting and control of use of private lands and provides for a fine of up to \$1,000 for trespassing and for restitution of up to \$1,000 to the landowner for damage to his property. A Guide to explain the legislation is currently being prepared and will soon be available through government sources.

A letter to the Editor

THE TRAIL USERS CODE

-Hike only along marked routes. -Do not climb fences, use the stiles. -Carry out all garbage (if you can carry it in, you can carry it out). -Light cooking fires at official campsites only - drench fires after use (better still, carry lightweight hiker's stove).

-Leave flowers and plants for others to enjoy. -Never strip bark from trees. -Protect and do not disturb wildlife. -Keep dogs on the leash on or near farmland.

-Walk around the edges of fields, not across them.

-Leave only your thanks and take nothing but photographs.
